1. Decision summary

The Delegated Officer has determined to make amendments to Licence L9124/2018/1 for a change in occupier name from Karora (Lakewood) PTY LTD into Black Cat (Lakewood) PTY LTD.

The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence L9124/2018/1, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Application summary

Licence L9124/2018/1 is held by Lakewood Mining Pty Ltd (licence holder) for the Lakewood Gold Processing Facility, Mining Tenements M26/242 and M26/367 (the premises), located at Mount Monger Road, LAKEWOOD WA 6431.

The premises relates to the category 5, 61 and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L9124/2018/1.

On 23 April 2025, the Licence Holder applied to the department to amend Licence L9124/2018/1 under section 59 and 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to change the licence holder's name.

3. Consultation

The Licence Holder provided with the draft Licence and Amendment Report on 26 May 2025. Comments received from the Licence Holder on 05 June 2025 have been considered by the Delegated Officer.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an Amended Licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
