## Amendment

## Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This notice is limited only to an amendment for Category 64. No changes to the aspects of the original licence relating to Categories 61 and 62 have been requested by the Licence Holder.

## Amendment description

The City of Busselton (Licensee) lodged an application on 2 February 2019 to alter the location of the asbestos disposal pit at the Vidler Road Putrescible Landfill Site.

The current asbestos disposal pit, cross hatched purple on the map, is nearing capacity. The new asbestos disposal pit, cross hatched orange on the map, is located within the existing void of the unlined landfill area. The existing landfill area is nearing its capacity, where the remaining void will be utilised for asbestos disposal only. Putrescible waste disposal will commence in Cell 1.

The proposal does not increase the current Premises design or capacity, and does not modify the types of waste to be disposed of at the Premises.

## Decision

The Delegated Officer notes the modification of the location for the disposal of asbestos is not expected to impact on the risk profile of the premises, as the volume of waste proposed to be disposed of at the Premises will not increase and the type of waste will not alter from that already approved of for disposal at the Premises.
