1. Decision summary

The Delegated Officer has determined to make amendments to Licence L9206. The amendment is administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the Existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Amendment summary

Licence L9206 is held by AAA Metal Recycling Pty Ltd (Licence Holder) for the AAA Metal Recycling (the Premises), located at 10 (Lot 9) Ocean Street Kwinana Beach WA 6167.

The Premises relates to the category 47 and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L9206.

On 31 March 2023, the department initiated an amendment to Licence L9206/2019/1. The amendment is limited to the following:

- updating occupier's registered Australian company number (119 775 727);
- renumbering of conditions;
- updating annual reporting period; and
- typographical errors.

3. Consultation

The Licence Holder was provided with the draft Amendment Report on 11 April 2023, however, no comments were received from the Licence Holder by 6 July 2023.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
