1. Decision summary

The Delegated Officer has determined to make amendments to Licence L9337/2022/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This amendment report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

2.2 Amendment summary

Licence L9337/2022/1 is held by Atlas Iron Pty Ltd (Licence Holder) for the Miralga Creek Direct Shipping Ore Project (the Premises), located on Mining tenement M45/1282, Abydos Link Road East, Marble Bar WA 6760.

The Premises relates to the category 5 and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L9337/2022/1.

On 8 September 2022, the Licence Holder informed the department that there was an omission of coordinates in Schedule 2 that define the prescribed premises boundary.

On 14 September 2022, the department initiated an amendment to Licence L9337/2022/1. The amendment is limited to updating the coordinates in Schedule 2 to correctly reflect the premises boundary. It does not alter the prescribed premises boundary, as shown in Schedule 1 of the licence.

3. Consultation

The Licence Holder was provided with the draft amendment report on 11 October 2022. On 13 October 2022 the Licence Holder waived the comment period.

4. Conclusion

Based on the assessment in this amendment report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments
