1. Decision summary

The Delegated Officer has determined to make amendments to Licence L9340/2022/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

2.2 Application summary

Licence L9340/2022/1 is held by IB Operations Pty Ltd (Licence Holder) for the North Star Magnetite Project (the Premises). The Premises relates to the category and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L9340/2022/1.

On 3 April 2025, the Licence Holder submitted an application to the department to amend Licence L9340/2022/1 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to the change of reporting dates specified in Condition 3 of the licence to align with other Fortescue Ltd operational licenses.

3. Consultation

The Licence Holder was provided with the draft Amendment Report on 11 June 2025. On 11 June 2025 the Licence Holder waived the comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised licence as part of the amendment process.
