## 1. Decision summary

The Delegated Officer has determined to make amendments to Licence L9343/2022/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

## 2. Scope of assessment

#### 2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <a href="https://dwer.wa.gov.au/regulatory-documents">https://dwer.wa.gov.au/regulatory-documents</a>.

#### 2.2 Amendment summary

Licence L9343/2022/1 is held by B. & J. Catalano Pty Ltd (Licence Holder) for the Runnymede Road Quarries (the Premises), located at Runnymede Road, Wellesly, WA 6233.

The Premises relates to the category and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L9343/2022/1.

On 5/05/2023, the Licence Holder submitted an application to the department to amend Licence L9343/2022/1 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited to changing the completion date of the construction of the 'Fines Storage Facility' from 31 March 2023 to 6 November 2023. There has a been a delay in constructing this facility and therefore the licence holder requires more time to complete construction. Extending the timeframe for construction has no impact on risk to the environment and therefore is accepted. This change is shown in Table 3 of licence L9343/2022/1.

#### 3. Consultation

The Licence Holder was provided with the draft Amendment Report on 6 June 2023. On 6 June 2023, the Licence Holder waived the comment period.

#### 4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
