1. Decision summary

The Delegated Officer has determined to transfer Licence L9394/2023/1 from the existing licence holder, Sims Group Australia Holdings Ltd to Ngardimu Pty Ltd. The transfer is administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the transfer made pursuant to section 64 of the *Environmental Protection Act 1986* (EP Act). The decision report for the existing Licence L9418/2023/1 will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

2.2 Transfer application summary

Licence L9394/2023/1 is held by Sims Group Australia Holdings Ltd (Licence Holder) for the Sims Metal, (the Premises), located at Coolawanyah Road, Karratha Industrial Estate, Karratha.

The Premises relates to the category and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L9394/2023/1.

On 16 December 2024, the Licence Holder submitted an application to the department for a transfer of licence L9394/2023/1 under the section 61 of the *Environmental Protection Act 1986* (EP Act).

The transfer application is limited only to changing the Licence holder's name (Occupier's name) from Sims Group Australia Holdings Ltd to Ngardimu Pty Ltd, updating occupier's registered business address, Australian Company Number (ACN) from 008 634 526 to 66 807 7030, and updating premises name from Sims metal to Ngardimu Pty Ltd.

3. Consultation

The Licence Holder was provided with the draft Amendment Report on 21 February 2025.

On 10 March 2025 the Licence Holder waived the comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments
