1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W5172/2012/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Application summary

Works Approval W5172/2012/1 is held by API Management Pty Ltd (Works Approval Holder) for the West Pilbara Iron Ore Project – Stage 1 (Putrescible Landfill) (the Premises), located at Mining Tenement L08/68, Cane WA 6710.

The Premises relates to the category and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W5172/2012/1.

On 18 November 2020, the Works Approval Holder applied to the department to amend Works Approval W5172/2012/1 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to extending works approval expiry date due to delays caused by the COVID-19 pandemic.

3. Consultation

The Works Approval Holder was provided with the draft Amendment Report on 10 December 2020. On 11 December 2020 the Works Approval Holder waived the comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
