## 1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W5399/2013/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the Existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

## 2. Scope of assessment

### 2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

### 2.2 Application summary

Works Approval W5399/2013/1 is held by Murrin Murrin Operations Pty Ltd (works approval holder) for the Murrin Murrin Nickel and Cobalt Project (the premises), located on mining tenements M39/420, M39/421, M39/423, M39/848 and M39/1066.

The Premises relates to the category and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W5399/2013/1.

On 24 April 2025, the works approval holder submitted an application to the department to amend Works Approval W5399/2013/1 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to extending the works approval time limited operations period from 180 days to 360 days. This is to allow time for the infrastructure to transition to a licence. An amendment for the licence has been submitted and is under assessment.

## 3. Consultation

The Works Approval Holder was provided the draft Amendment Report and draft Works Approval on 11 June 2025. The Works Approval Holder responded to the department on 11 June 2025 and advised that there were no comments on the proposed amendment and requested to waive the remainder of the consultation period.

## 4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

### 4.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised works approval as part of the amendment process.
