## 1. Decision summary

The Delegated Officer has determined to transfer Works Approval W5843/2015/1 and Licence L9185/2018/1 to WMines Limited for Burbank's Treatment Plant (the Premises). The transfer is administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

The decision and amendment reports for the existing licence and works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

### 2. Scope of assessment

### 2.1 Regulatory framework

In completing the assessment documented in this decision report, the Department of Water and Environmental Regulation (the department; DWER) has considered and given due regard to its regulatory framework and relevant policy documents which are available at <a href="https://dwer.wa.gov.au/regulatory-documents">https://dwer.wa.gov.au/regulatory-documents</a>.

### 2.2 Application summary and overview of premises

On 30 March 2023, an application was submitted to the department for a transfer of works approval (W5843/2015/1) and licence (L9185/2018/1) under section 54 of the *Environmental Protection Act 1986* (EP Act).

The application is to transfer works approval W5843/2015/1 and licence L9185/2018/1 from Coil Group Pty Ltd to WMines Limited.

The application is limited to a review of ownership details to determine if a transfer may occur. There are no proposed changes to the current approved premises categories or associated design capacity.

The Premises relates to the Category 5: Processing or beneficiation of metallic or non-metallic ore and assessed production capacity under Schedule 1 of the *Environmental Protection Regulations* 1987 (EP Regulations) which are defined in works approval W5843/2015/1 and licence L9185/2018/1.

The new occupier details have been reviewed against the Australian Securities and Investment's Commission (ASIC) register. WMines Limited's registered company name, Australian Company Number (ACN) and address have been confirmed as correct.

The only changes made to the licence and works approval under this transfer include:

- Licence Holder/ Works Approval Holder name change from Coil Group Pty Ltd to WMines Limited;
- ACN updated; and
- · Registered business address updated.

#### 3. Conclusion

The delegated officer has determined that the works approval W5843/2015/1 and licence L9185/2018/1 will be transferred.
