1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W5903/2015/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the Existing Works Approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the Works Approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Amendment Works Approval summary

This amendment is limited to a transfer of Works Approval W5903/2015/1 from Aussie Organics Garden Supplies Pty Ltd to Aussie Compost and Carbon Solutions Pty Ltd.

This transfer was made at the request of Aussie Compost and Carbon Solutions Pty Ltd on 24 May 2021. The assessment of the Works Approval transfer application is limited to a review of ownership details to determine if a Works Approval transfer may occur.

There are no proposed changes to the current approved Premises categories or design capacity.

The obligations of the Works Approval Holder have not changed in the revision of the Works Approval and the transfer is limited to:

- · updating registered company name; and
- updating occupier registered company address.

3. Consultation

The applicant, Aussie Compost and Carbon Solutions Pty Ltd was provided with the draft Amendment Report on 5 August 2021. A reply email confirming no comments to proposed amendment was received on 11 August 2021.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended Works Approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
