## 1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W5912/2015/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

As a result of this amendment, the duration of the Works Approval has been extended to 30 June 2021 consistent with current planning approval from the Shire of Chittering.

## 2. Scope of assessment

#### 2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <a href="https://www.der.wa.gov.au">https://www.der.wa.gov.au</a>.

#### 2.2 Application summary

Works Approval W5912/2015/1 is held by Swan Waste Solutions Pty Ltd (Works Approval Holder) for Swan Waste Solutions (the Premises), located at Lots 202 and 203 on Plan 46016 Wandena Road, Muchea.

The Premises relates to categories 13 and 61A and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W5912/2015/1.

On 16 June 2020, the Works Approval Holder submitted an application to the department to amend Works Approval W5912/2015/1 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to extending works approval expiry date to 31 June 2021 to align with the current Development Approval and updating the occupiers registered address.

#### 3. Consultation

The Shire of Chittering (the Shire) were consulted as part of the amendment process to determine if Development Approval was still valid. The Shire advised that development approval for the Premises would be valid until July 2021, however a further application for Development Approval had recently been submitted to extend this timeframe for a further 10 years. The Shire advised that this application was currently in process but may not be finalised prior to the expiry of the current Works Approval.

The Works Approval Holder was provided with the draft Amendment Report on 10 July 2020 and confirmed acceptance of the revised Works Approval on 14 July 2020.

#### 4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

The expiry date has been extended to 30 June 2021 for consistency with the current Development Approval for the site. This is consistent with DWER's *Guideline: Industry Regulation Guide to Licensing*. If an extension is granted to the Development Approval, a

further amendment may be sought by the Works Approval Holder to further extend the duration of the Works Approval.

## 4.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised works approval as part of the amendment process.
