1. **Decision summary**

The Delegated Officer has determined to amend works approval W6047/2017/1. The amendment is administrative in nature and therefore does not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This amendment report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986 (EP Act)*.

The decision report for the existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

1.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <u>https://dwer.wa.gov.au/regulatory-documents</u>.

1.2 Application summary

Works approval W6047/2017/1 is held by Altech Meckering Pty Ltd (Works Approval Holder) for the Meckering Kaolin Project (the Premises), located at mining tenement M70/1334 in Meckering WA, 6407.

The Premises operates under Category 5 – Processing or beneficiation of metallic or nonmetallic ore as per Schedule 1 of the Environmental Protection Regulations 1987 (EP Regulations), with an assessed production capacity of 42,500 tonnes processed per annual period.

On 15 June 2023, the Works Approval Holder submitted an application to the department to amend works approval W6047/2017/1 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment being sought is administrative in nature and is limited to extending the works approval expiry date, with no other changes requested. The Works Approval Holder is seeking an extension of two years until December 2026 to close project financing.

The Delegated Officer has extended the duration of the works approval by an additional year to 27 December 2027. This extension was not only intended to ensure that the Works Approval Holder has adequate time to complete the required work, but also to provide the department with time to assess the relevant compliance reports upon completion of works.

2. Consultation

The Works Approval Holder was provided with the draft Amendment Report on 12 July 2023. On 13 July 2023, the Works Approval Holder waived the 21 day consultation period.

3. Conclusion

Based on the assessment in this amendment report, the Delegated Officer has determined that an amended works approval will be granted until December 2027, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
