1. Decision summary

The Delegated Officer has determined to make amendments to works approval W6283/2019/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the Existing Works Approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the Works Approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Amendment summary

Works Approval W6283/2019/1 is held by Talison Lithium Australia Pty Ltd (Licence Holder) for the Talison Lithium Mine, Maranup Ford Road, Greenbushes, WA 6254 (the Premises), located at Part of mining lease tenements M01/3, M01/6, M01/7, M01/8, M01/9 Whole of leases M1/16, G01/1, G01/2.

The Premises is approved for category 5 operations and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) are defined in existing Works Approval W6283/2019/1.

On 4 November 2020, the Works Approval Holder applied for an amendment to W6283/2019/1 to update the registered business address. The department has also used this amendment as an opportunity to update formatting and to correct errors. This amendment is limited to:

- updating occupier's registered company address;
- correcting a typographical error in the premises address;
- updating/deletions/inclusion of definitions, etc.

3. Consultation

On 22 December 2020 the Works Approval Holder waived the comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended Works Approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
