1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6323. The amendments are administrative in nature therefore they do not alter the risk profile of the premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the Existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <u>https://dwer.wa.gov.au/regulatory-documents</u>.

2.2 Amendment summary

Works Approval W6323/2019/1 is held by Billabong Gold Pty Ltd (Works Approval Holder) for the Plutonic Gold Mine (the premises), part of mining tenements mining tenements M52/148 and M52/170.

The premises relates to the category and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which is defined in existing Works Approval W6323/2019/1.

On 22 December 2022, the Works Approval Holder submitted an application to the department to amend Works Approval W6323/2019/1 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to extending works approval expiry date to allow more time for the completion of construction works.
