1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6342/2020/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the Existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

2.2 Amendment summary

Works Approval W6342/2020/1 is held by Mt Magnet Gold Pty Ltd (Works Approval Holder) for the Mt Magnet Gold (the Premises), located at Mining tenements M58/121, M58/193 and M58/205 MOUNT MAGNET WA 6638.

The Premises relates to the category and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6342/2020/1.

On 14 May 2025, the Works Approval Holder submitted an application to the department to amend Works Approval W6342/2020/1 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to extending works approval expiry date and does not propose changes to the method of operation, or change to the inputs, outputs, infrastructure, equipment, emissions, or discharges of / from the premises as detailed in the Works Approval granted under W6342/2020/1.

Not all embankment raises have been completed as per table 2 of Works approval W6342/2020/1 due to operations requirements. The remainder embankment raises will occur over the next 5 years. The most recent embankment raises for each Tailing Storage Facility (TSF) at the time of this report are mentioned in the following table.
