1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6349/2020/1. The amendments are administrative in nature therefore they do not alter the risk profile of emissions and discharges from the Premises.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

2.2 Amendment summary

Works Approval W6349/2020/1 is held by Puma Energy (Australia) Bitumen Pty Ltd (Works Approval Holder) for the Puma Energy Kwinana (the Premises), located at 49 Port Road, Kwinana Beach, WA 6167.

The Premises relates to the category and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6349/2020/1.

The Works Approval Holder is within a six month period of time limited operations under the works approval that is due to cease on 17 November 2021. As the Works Approval Holder is completing validation monitoring and is preparing to lodge an application for a licence, the department initiated an amendment of the works approval. The amendment is limited to:

- extending the works approval expiry date from 2 July 2023 to 2 July 2025 to provide the Works Approval Holder additional time to implement stage 2 of its works (if applicable); and
- extending the time limited operations period as specified in condition 5(a) by an additional four months to provide sufficient time for the processing of a Licence application for the premises.

3. Consultation

The Works Approval Holder was provided with drafts of the amended works approval and this report for comment on 24 September 2021. The Works Approval Holder responded on the 20 October 2021 advising they had no comments to make on the draft documents.

4. Decision

The Delegated Officer determined to extend the works approval expiry to 2 July 2025. This is considered reasonable on the grounds that the aggregate duration of the works approval will be five years in total and provide the Works Approval Holder with additional time to implement stage 2 of the project, should it wish to do so.

The Delegated Officer considered a four month extension of time limited operations to be reasonable on the grounds that it provides sufficient time for the department to process a

licence application, including consideration of works approval compliance reports and the Works Approval Holder's verification monitoring data.

The amendments are administrative in nature and do not change the risk profile of emissions and discharges from the Premises.

5. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

5.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised works approval as part of the amendment process.
