## 1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6364/202/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

## 2. Scope of assessment

## 2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <a href="https://dwer.wa.gov.au/regulatory-documents">https://dwer.wa.gov.au/regulatory-documents</a>.

#### 2.2 Amendment summary

Works Approval W6364/202/1 is held by Evolution Mining (Mungari) Pty Ltd (Works Approval Holder) for the Mungari Gold Mine (the Premises), located within mining tenements M15/829 and M15/830.

The Premises relates to the category and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6364/202/1.

On 5 June 2024, the Works Approval Holder submitted an application to the department to amend Works Approval W6364/2020/1 under section 59B of the *Environmental Protection Act* 1986 (EP Act). The amendment is limited only to extending the works approval expiry date.

Works Approval W6364/2020/1 allows for the construction of two tailing storage facilities (TSF) cells 3 and 4 at the premises including the starter embankment (stage 1) and two embankment lifts (stage 2 and 3) for each cell. The extension of the expiry date is to allow the completion of construction of stage 3 for each cell. The requested new expiry date is 9 September 2028 (four year extension). The works approval holder plans to submit a works approval amendment application in the near future for stages 4 through to 10 for cells 3 and 4.

#### 3. Consultation

The Works Approval Holder was provided with the draft Amendment Report and Works Approval on 9/08/2024. On 13/08/2024 the Works Approval Holder waived the comment period.

#### 4. Conclusion

The Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

## 4.1 Summary of amendments
