1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6381/2020/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at [DWER Regulatory documents | Western Australian Government \(www.wa.gov.au\)](https://www.wa.gov.au/government/publications/dwer-regulatory-documents).

2.2 Application summary

Works Approval W6381/2020/1 is held by Cockburn Cement Limited (Works Approval Holder) for the Cockburn Cement Kwinana Plant (the Premises), located at Lot 45 Leath Road, Kwinana Beach.

The Premises relates to the category and the assessed design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6381/2020/1.

On 7 December 2023, the Works Approval Holder submitted an application to the department to amend Works Approval W6381/2020/1 under section 59B of the *Environmental Protection Act 1986* (EP Act). The application relates only to a two year extension of the works approval expiry date from 31 March 2024 to 31 March 2026.

The application outlined reasons for the works approval extension relating to the current status of the project, revised commissioning and reporting plans and provides some flexibility for further potential project timeline changes.

3. Consultation

The Works Approval Holder was provided with the draft Amendment Report on 21 February 2024. The Works Approval Holder replied on 23 February 2024 accepting the amendment and waiving the 21 consultation period.

4. Decision

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

The works approval is to be amended to extend its duration by two years until 31 March 2026. This is considered reasonable taking into account the reasoning in the application. An administrative update was also made to change the premises name from 'Kwinana Cement and Lime Manufacturing Facility' to 'Cockburn Cement Kwinana Plant' to be consistent with the terminology in the application.

4.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised works approval as part of the amendment process.
