1. Decision summary

The Delegated Officer has determined to transfer Works Approval W6389/2020/1 to Yilgarn Iron Pty Ltd. This Decision Report documents the transfer made pursuant to section 64 of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In transferring the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

2.2 Application summary

Works Approval W6389/2020/1 is currently held by Polaris Metals Pty Ltd for the Parker Range Iron Ore Project (the Premises). The Premises relates to the categories and the assessed production capacity under Schedule 1 of the Environmental Protection Regulations 1987 (EP Regulations) which are defined in existing Works Approval W6389/2020/1.

On 4 April 2025, Yilgarn Iron Pty Ltd (the applicant) submitted an application to the department to transfer the works approval from Polaris Metals Pty Ltd to Yilgarn Iron Pty Ltd. Both Polaris Metals Pty Ltd and Yilgarn Iron Pty Ltd are wholly owned subsidiaries of Mineral Resources Limited and share common directors.

3. Decision

A review of the occupier status of the applicant was carried out to determine if a transfer of the works approval may occur. A review of the compliance history of any current licenses or works approvals held by the applicant was also undertaken. It has been determined that:

- Yilgarn Iron Pty Ltd is a registered and valid company and is therefore a legal entity that can hold a works approval under Part V of the EP Act.
- There are no significant compliance matters relating to Yilgarn Iron Pty Ltd or its directors, that would prevent the granting of this transfer.
- Yilgarn Iron Pty Ltd has provided evidence that they are the current occupier of the premises (mining tenements M77/741, M77/742 and M77/764). Evidence was provided in the form of mining tenements summary reports confirming the holder of the mining tenements which make up the premise boundary.

Based on the assessment in this transfer report the Delegated Officer has determined to transfer works approval W6389/2020/1 from Polaris Metals Pty Ltd to Yilgarn Iron Pty Ltd.

3.1 Summary of amendments

Table 1 below provides a summary of the amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised works approval as part of the transfer process.
