1. Amendment description

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the existing works approval issued under the EP Act for a prescribed premises as set out below. This notice of amendment is hereby given under section 59B(9) of the EP Act.

This amendment is limited to the extension of the works approval expiry date by one (1) year. No other changes to existing conditions have been requested by the works approval holder.

In completing the assessment documented in this report, the department has considered and given due regard to its regulatory framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2. Proposed amendment

Works Approval W6490/2021/1 is held by Derby Industries Pty Ltd (works approval holder) for the Talloman Rendering Facility (the premises), located at Lot 115 Lakes Road Hazelmere. The existing works approval outlines the construction of a new low temperature poultry processing line and is due to expire on 15 June 2025.

The premises relates to Category 16: Rendering operations and the assessed production capacity of 180,000 tonnes per annual period under Schedule 1 of the *Environmental Protection Regulations* 1987 (EP Regulations) which are defined in the existing works approval.

On 22 April 2025 the works approval holder submitted an application to the Department of Water and Environmental Regulation (the department) to amend Works Approval W6490/2021/1 under section 59 and 59B of the *Environmental Protection Act 1986* (EP Act). The amendment proposed an extension of the works approval expiry date by 1 year, moving the expiry from 15 June 2025 to 15 June 2026.

3. Decision

The Delegated Officer has determined to extend the duration of the existing works approval (W6490/2021/1) as an administrative change, on the basis that the works approval is set to expire on the 15 June 2025, this extension does not change the obligations of the works approval holder.

The works approval duration will be extended by 1 year, now expiring on the 15 June 2026.

The amendment is administrative in nature; therefore, it does not alter the risk profile of the premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

4. Consultation

The works approval holder was provided with a first draft of the revised Works Approval and Amendment Report on 3 June 2025. No comments were received, and the consultation period was waived by the works approval holder.

5. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
