1. Decision summary

The Delegated Officer has determined to make amendments to works approval W6510/2021/1. The amendments are administrative in nature therefore they do not alter the risk profile of the premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This amendment report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its regulatory framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Amendment summary

Works approval W6510/2021/1 is held by Blue Phoenix Western Australia Pty Ltd (works approval holder) for the Hope Valley IBA Facility (the premises), located at 67 Investigator Drive, Hope Valley.

The premises relates to the category and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing works approval W6510/2021/1.

On 7 January 2025, the department initiated an amendment to works approval W6510/2021/1 in response to a request from the works approval holder to correct minor errors present in the version of the works approval granted on 13 December 2024.

This administrative amendment is limited to correcting minor administrative, formatting and referencing errors as outlined in Table 1 below.

3. Consultation

The works approval holder was provided with the draft amendment report on 10 January 2025. On 13 January 2025, the works approval holder requested to amend the wording of condition 14(b) to align with wording in Table 2 of the works approval and waived the comment period. The request has been approved by the Delegated Officer.

4. Conclusion

Based on the assessment in this amendment report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
