1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6640/2022/1. The amendments are administrative in nature and therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Amendment summary

Works Approval W6640/2022/1 is held by Aurenne MIT Pty Ltd (Works Approval Holder) for the Mt Ida Gold Project, Bottle Creek Premises (the Premises).

The Premises relates to the categories and the assessed design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6640/2022/1.

On 21 August 2023, the department initiated an amendment to Works Approval W6640/2022/1. The amendment is limited to updating cross refencing errors to figures and tables in works approval.

3. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
