1. Decision summary

On 4 August 2023, the Minister for Environment made his determination of a third-party appeal (Appeal number 031 of 2022) against a Works Approval granted on 28 July 2022, allowing the construction and time-limited operation of a Category 85: Sewage facility and associated spray-field, and a Category 89: Putrescible landfill to service the Lake Wells Potash Project.

In making his determination the Minister determined to allow in part to the extent that the works approval is amended to:

- Protect native fauna from an increased risk of predation from feral animals, attracted by landfill waste and artificial water sources; and
- Ensure that the environmental performance of the landfill, WWTP and spray-field is assessed and reported to the department.

Changes have been made to align works approval conditions with the Minister's recommendations. These are summarised in Table 1. As the amendment is given effect to an appeal decision, no further risk assessment to justify these changes is required/provided within this Decision Report.

2. Consultation

The Works Approval Holder was provided with the draft Amendment Report on 6 October 2023. No comments were received from the Works Approval Holder.

3. Conclusion

Based on this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

3.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised works approval as part of the amendment process.
