1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6724/2022/1 held by Golden Spur Resources Pty Ltd (Works Approval Holder) for the Bellevue Gold Project (the Premises), located within mining tenement M36/24 and M36/25. The amendments are administrative in nature and therefore do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

2.2 Amendment summary

On 21 May 2024, the department initiated an amendment to Works Approval W6724/2022/1. The amendment is limited to extending the works approval Time Limited Operation (TLO) period by an additional 180 calendar days to allow sufficient time for the licence amendment application for L9259/2020/1 to be assessed by the department.

The Premises relates to categories 5 and 6 and the assessed design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6724/2022/1.

3. Decision

The Delegated Officer has determined that extending the TLO period for items 1 – 5 (as per condition 12 of the Works approval) by 180 days will not alter the nature of emissions from the infrastructure or alter the risk profile of the premises during operations. The current works approval conditions are considered sufficient to manage any risk for the extended duration of TLO. The amended TLO period expires on 12 December 2024.

4. Consultation

The Works Approval Holder was provided with the draft Amendment Report on 29 May 2024 and provided no comments on the draft conditions.

5. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

5.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised works approval as part of the amendment process.
