1. Decision summary

The Delegated Officer has determined to make amendments to works approval W6759/2022/1. The amendments are administrative in nature therefore they do not alter the risk profile of the premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Amendment summary

Works approval (W6759/2022/1) is held by Cleanaway Co Pty Ltd (works approval holder) for the Karratha Liquid Waste Treatment Plant and Waste Transfer Station (the premises), located at Lot 126 Warlu Road, Cooya Pooya, WA 6714.

The premises relates to the categories and the assessed design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing works approval W6759/2022/1.

On 14/03/2023, the Department of Water and Environmental Regulation (DWER) initiated an amendment to works approval W6759/2022/1. The amendment is limited to addressing an administrative error, identified by the works approval holder. The works approval holder identified that an incorrect batter slope was referenced in Table 5, Schedule 2 of the works approval. Construction requirements of the internal batter slopes as detailed in the design specifications of the original works approval were 1:2 (V:H).

3. Consultation

The works approval holder was provided with the draft Amendment Report on 20 March 2023. On 13 April 2023 the works approval holder requested to waive the remainder of the comment period and grant the work approval with no further changes.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the revised works approval as part of the amendment process.
