1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6859/2023/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the Existing Works Approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Application summary

Works Approval W6859/2023/1 is held by Pilgangoora Operations Pty Ltd (Works Approval Holder) for the Pilgangoora Operations (the Premises), located at Mining tenements M45/1230 and M45/1260, MARBLE BAR WA 6760.

The Premises relates to the category and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations* 1987 (EP Regulations) which are defined in existing Works Approval W6859/2023/1.

On 27 May 2025, the Works Approval Holder submitted an application to the department to amend Works Approval W6859/2023/1 under section 59B of the *Environmental Protection Act* 1986 (EP Act). The amendment is limited only to the removal of Critical Container Infrastructure design, construction and reporting requirements for the tailing storage facility (TSF) TSF3 Stage 2.

Critical containment infrastructure for TSFs refers primarily to the first stage of a tailing facility where the department assess the environmental controls, which will be in place before the operational phase (DWER 2019).

The TSF3 Stage 2 does not classify as a critical containment, as it is a lift from the TSF, hence, the department agrees with the proposed amendment.

To date, the TSF3 Stage 1 has not been constructed or any of the infrastructure listed in the Works Approval.

3. Consultation

The Works Approval Holder was provided with the draft Amendment Report on 19 August 2025. Minor administrative comments were received from the Works Approval Holder on 26 August 2025 and have been considered by the Delegated Officer and incorporated in the final version of the Works Approval.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the

determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised works approval as part of the amendment process.
