2.1. Purpose and scope of assessment

The Water Corporation submitted an application to amend Works Approval W5805/2015/1 on 13 December 2019. The amendment relates to an extension of the works approval expiry date. No changes to any other aspects of the original works approval have been requested by the Works Approval Holder.

Water Corporation have indicated that the original project schedule was being driven by a predicted increase in water demand at Onslow. As the water demand growth has not materialised, project completion has been pushed out, requiring an extension to the works approval expiry date.

2.2. Consolidation of Works Approval

As part of this amendment package DWER has updated the works approval by incorporating the following changes:

- updated the format and appearance of the Works Approval;
- revised works approval condition numbers, and removed any redundant conditions and realigned condition numbers for numerical consistency; and
- corrected clerical mistakes and unintentional errors.

The obligations of the Works Approval Holder have not changed in updating the works approval. DWER has not undertaken any additional risk assessment of the Premises as a part of this process.

The Delegated Officer has determined that the extension of the Works Approval expiry date is an administrative amendment which does not alter the risk profile of the premises. The works shall be undertaken in accordance with the amended Works Approval issued 17/03/2020, and there is to be no change in the potential emissions associated with the development of the facility. The Works Approval expiry date has been amended as shown below:

The Works Approval expiry date has been extended from 26 March 2020 to 26 March 2023.
