1. Decision summary

The Delegated Officer has determined to make amendments to Licence L9212/2019/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The Decision Report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

2.2 Application summary

Licence L9212/2019/1 is held by Washington's Earthmoving Pty Ltd (Licence Holder) for Rock 'N Rubble Solutions (the Premises), located at 13 Keates Road, Armadale, WA.

The Premises relates to the categories and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L9212/2019/1.

On 17 June 2020, the Licence Holder submitted an application to the department to amend Licence L9212/2019/1 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to updating the Licence Holder's registered business address and premises name.

3. Consultation

The Licence Holder was provided with the draft Amendment Report on 8 July 2020. Comments received from the Licence Holder on 29 July 2020 have been considered by the Delegated Officer as detailed in Appendix 1.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
