

As per Table 1.3.2: Waste Processing, only hydrocarbon contaminated soil is to be remediated within the bioremediation facilities. During the FY2023 reporting period, suspected sludge from the decommissioned ANFO facility had been deposited at the bioremediation facility. No bioremediation activities occurred during the FY2023 reporting period.

As per licence Table 1.3.4: The Oily waste evaporation pond is required to be lined with 1.5mm HDPE lined cells to achieve a permeability of $<10^{-9}$ m/s. BHP identified that the ponds are no longer lined.

Facility has been decommissioned and infrastructure removed. Evidence of potential residual residue in the ponds was identified.

During a cyclone event, potentially contaminated stormwater discharged from point W1 into Eel creek or any additional potentially contaminated areas without being treated.			
What was the actual (or suspected) environmental impact of the non-compliance?

No expected environmental impact from this event is expected due to the large amount of rain sustained in the area and low potential of stormwater contamination from decommissioned onsite infrastructure.

Cyclone activity and associated extreme rainfall event flooded site operational areas and eroded stormwater diversion bunds.			
Action taken to mitigate any adverse effects of non-compliance and prevent recurrence of the non-compliance:			
Reinstatement of stormwater diversions bunds will be completed in FY2024 and further inspections of potentially contaminating infrastructure will be completed.

<p>During a cyclone event, monitoring at point W1 (contingency discharge point to Eel Creek), monitoring was meant to occur. Due to safety constraints during and after the cyclone, samples were not able to be captured.</p> <p>No meter was found at this location. It potentially has been washed out due to cyclone.</p>
