Inert Waste Type 2 – Tyres	metal & wire was collected & taken away by Sims Metal Pty Ltd for recycling.
Putrescible Waste	1,713.573 tonnes of inert waste was received and disposed of on-site. 1,688.88 tonnes of solid waste (building & construction waste) was also received.
	392 mattresses including ensemble bases were collected & taken by Cleanaway to Meru Waste Management Facility in Geraldton. This number is three times what we normal receive due to Cyclone Seroja damage.
	6.15 tonnes of tyres collected & disposed of off-site in Geraldton by Cleanaway.
	156.60 tonnes of putrescible waste were collected in skip bins at the Transfer Station area & taken by Cleanaway to Meru Waste Management Facility in Geraldton. This figure increased from normal due to power outage after Cyclone Seroja.
	390.255 tonnes of greenwaste were collected at the Facility & burnt after being allowed to dry out for at least 3 months.
	Estimated 1,008.0m3 of cardboard was collected in skip bins at the Transfer Station area & taken by Cleanaway to Geraldton.
	Estimated 211.773m3 of bonded asbestos & 10.0m3 of asbestos contaminated soil (total 2.883 tonnes) was received & disposed of on-site.
