Details of non-compliance:

Landfill waste not covered in accordance with licence conditions. The City was operating without the Tana and hired a bulldozer to complete required compaction and daily cover operations. The wet conditions over winter and into spring also made the application of ADC an ongoing concern.

What was the actual (or suspected) environmental impact of the non-compliance?

Release of odour emissions. Increased pests at the landfill. Increased water and decay of waste on the active face of the landfill.

Cause (or suspected cause) of non-compliance:

Weather conditions and machinery breakdowns and limited access to hire equipment. Also staff shortages in terms of machine operators.

Action taken to mitigate any adverse effects of non-compliance and prevent recurrence of the non-compliance:

Application of sand to reduce odours. Stockpiling on cover materials onsite.

The internal sprinkler system was removed March 2022 as the transfer station was shifted to the
new platform. The City is working with the DWER on a licence amendment for operating at the
new transfer station location.

There has been no implications from this non-compliance as there has been no fires. The sprinkler system was used mainly for dust suppression and could not reduce the severity of a landfill fire. The City will seek to have this condition removed and updated with reference to the current emergency management plan. Access to water is maintained onsite for fire suppression and the City liaises with DFES and contacts them in the event of a fire.
