Litter can escape the premises with high winds. It is suspected that the land surrounding the operational landfill area is impacted by escaped litter.			
Note, the whole landfill area is approximately 4 times as large as the operational landfill areas and that the site in not located in proximity to any residential areas. Additionally the site is located in between hills which is also used as a barrier to reduce litter blowing to far from the site.			
Cause (or suspecte	ed cause) of non-compliance:		
The topography of the land surrounding the boundary of the landfill site, where fencing is required, is extremely hard and not level. Due to these factors, installing boundary fencing requires significant allocation of funds. The funds for the completion of this project have not yet been allocated.			
Action taken to mitigate any adverse effects of non-compliance and prevent recurrence of the non-compliance:			
The land surrounding the operational landfill area is inspected daily and cleaned where necessary.			
The Shire has fenced 360 metres of the 3490 metre boundary. It is proposed that this work is completed in stages as funds are allocated in the Shire's budgets over the coming financial years.

The Shire is currently engaged with the local government insurance service (LGIS) regarding the damage to the sludge drying, and ways to fix it. Also, a request for quotation (RFQ) has been completed by the Shire for a condition assessment of the liquid waste facility. Submissions have been reviewed, and the project will be awarded soon.
