During flushing of the TSF tailings discharge line with process water following routine maintenance, process water was not fully contained within the pipeline secondary containment due to a scour pit valve failure.  Most of the process water was captured within a scour pit and the pipeline bund. Approximately 20 m3 escaped the pipeline bund and was contained to an adjacent low-lying area within the operational (disturbed) footprint.

This is a technical non-compliance with licence condition 3.3.1. Inspection records were missed on occasion.  No environmental impact has occurred due to the non-compliance.

TSF and dewatering pipeline and discharge point inspections were not recorded every day during the reporting period (36 of 365 TSF and 14 of 365 dewatering pipeline inspections). In most instances inspections were completed however not formally recorded in the log book due to new personnel and/or supervision availability.				
Action taken to mitigate any adverse effects of non-compliance and prevent recurrence of the non-compliance:				
Communication and training was undertaken with processing personnel on the requirements that inspections of inactive infrastructure must be undertaken and recorded.  The requirements for maintaining daily inspection records are included in the relevant management plans.
