Details of non-compliance:

Following the end of the 2023-2024 reporting period, the total volume of sewage sludge was calculated. Subsequently it was determined the total volume accepted at the Beenyup WRRF was above the licenced limit of 50,000 tonnes at 55,545 tonnes.

What was the actual (or suspected) environmental impact of the non-compliance?

There is no suspected or actual environmental impact of this non-compliance. Despite the increased sludge received, the Beenyup WRRF was able to maintain effective treatment.

Cause (or suspected cause) of non-compliance:

The higher volume of sludge for this period was attributed to growth within the Alkimos catchment and additional sludge received from the Subiaco Waste Water Resource Facility due to the Amargh Street Sewer Diversion.

Action taken to mitigate any adverse effects of non-compliance and prevent recurrence of the non-compliance:

Final effluent monitoring indicates Beenyup WWRF is continuing to treat wastewater to a high standard. The majority of treated wastewater is sent to the Beenyup Advanced Water Recycling Plant for further treatment. Risks to people and the environment are considered low. Water Corporation will continue to monitor sludge volumes and effluent quality and progress long term planning for the catchment and the WRRF.
