## Section E - Details of non-compliance with licence condition Please use a separate page for each condition with which the licence holder was non-compliant at a time during the reporting period. 3.4.1 – ambient water quality monitoring Date(s) of non-Condition no: Various compliance: 3.5.1 – ambient dust and weather monitoring Details of non-compliance: The following minor non-conformances against environmental monitoring programs occurred in 2024: Ambient Water Quality Monitoring Groundwater abstraction and water level gauging records fully complied with Groundwater Licence Operating Strategy (GLOS) requirements in 2024. However, the commitment for quarterly field EC/pH/Temp readings was not completely achieved and although quarterly water quality sampling rounds were undertaken, not all bores were sampled in all rounds. Annual major components analyses are required from all production bores under GWL commitments. Galaxy currently samples most of the borefield on a quarterly frequency, much higher than is required under GWL conditions. Galaxy sampled all production bores in the schedule, but three external monitoring bores were not sampled at all in 2024 (WTD11, 19, and 21A). High Volume Air Sampler HV01 (PM10) HVAS data was impacted on several occasions during 2024 (8 out of 61 sampling runs) where the filter paper was not replaced at the end of the 24-hour sample period and resulted in the re-sampling a second 24-hour sampling run. **Dust Deposition Gauge Sampling** The calendar month sample collection period for DDG sampling was not consistently attained in 2024, ranging from a sampling duration of 24 days in September to 43 days in October, versus the standard requirement of 30-days +/-2 days. Automatic Weather Station (AWS) AWS instruments were taken down for routine maintenance and servicing, resulting in the loss of sitespecific weather data from 22 September to 22 October 2024. Minor impact to the continuity of environmental monitoring datasets only. Cause (or suspected cause) of non-compliance: Mt Cattlin Operations have endured and responded to considerable and rapid operational transitions over the past 18 months. Associated effects (including increased staff-turnover rates) has impacted the ability to maintain 100% compliance with environmental monitoring regimes. Action taken to mitigate any adverse effects of non-compliance and prevent recurrence of the non-compliance: Further changes are now required as the site transitions to Care and Maintenance, and early planning and proposals for reduced monitoring commitments are underway. This noise was attributable to waste dump rehabilitation works and the construction of a new site access road at the base of WD3. These are considered construction activities (rather than normal mining operations) under <i>Western Australia Environmental Protection (Noise) Regulations 1997</i> , Regulation 13. The construction / rehabilitation activity would be compliant during weekdays, 7am – 7pm (Monday to Saturday inclusive). During Sundays and Public Holidays, construction that generates excessive noise is not compliant unless approved by the CEO (shire) under a Construction Noise Management Plan in accordance with Regulation 13.
