In 2023, TN loading reached 134 kg/ha, well below the specified limit of 300 kg/ha. Similarly, TP loading stood at 34 kg/ha, within the defined threshold of 50 kg/ha. Additionally, BOD was recorded at 0.83 kg/ha/day, remaining comfortably below the limit of 30 kg/ha/day.
