Discharge pipe was leaking onto waste water irrigation area from a cut approximately 250mm long 10m from the join where it changes to layflat flex hose. This non compliance has been rectified and was caused by careless operators of machinery, as well as the inspection of the waste water plant not being thorough enough. As soon as the leak was identified it was repaired.

Nutrient overload, surface pooling of waste water, Leaching into soil, nutrients soaking into soil and not being taken up by plants and subsequent removal.

No healthy vegetation cover was maintained in irrigation area, treated wastewater was not evenly distributed. This non compliance event has been, in my opinion, caused by a lack of training in waste water compliance from the licence holder and the leesee of the winery. Also it is obvious there has been a lack of open communication between the department and the licence holder.

Leaching into soil, nutrients soaking into soil and not being taken up by plants and subsequent removal.

Insufficient rainfall and lack of irrigation to maintain a healthy vegetation cover. No crop planting regime.

Liaise with DPIR on the best method to implement and maintain a healthy vegetation cover. Initiate irrigation as required to maintain a healthy vegetation cover.
