Regular monitoring of the storm water in Basin C indicated a Nitrogen level slightly above the level allowable in the license. A number of organizations were contacted in order to assist us with removing/reducing the level of nitrogen in the water. Over time, only one organization responded with a potential solution. They needed approximately 2 weeks to mobilize to site. The expected rainfall as advised by the Bureau of Meteorology (BOM) indicated that a significant rain event would occur before the solution would have been operational

Should the site flood a High Voltage sub-station would have been inundated, which would have provided an imminent threat to all of those in the vicinity, further leaving the site unusable.
