As per Condition 3(e), a noise compliance assessment report of combined Stage 1 and 2 operations was required to be submitted to DWER by 31st July 2022. Whilst the consultant was engaged well prior to this date, the required attended monitoring was not able to be carried out until later in the year (September and October 2022). This meant that the resulting report was not submitted to DWER until 12th December 2022.
