| The Westralia and Henderson monitoring bores were dry when constructed (Dec 2020) and continued to remain dry for the remaining 10 months they were monitored, therefore the SWL's and TDS monitoring could not be completed. | | | | |
| The SWL's of the remaining Vanguard monitoring bore was completed from December 2020 until September 2021, no TDS monitoring occurred during this time. Following this it is assumed the bores were destroyed and no monitoring occurred post September 2021. | | | | |

| The environmental impact of the TDS not being analysed and the monitoring ceasing in September 2021 is that an assessment of saline water mounding due to dewatering has not been able to be assessed. Four new monitoring bores were constructed around the Vanguard Pit in October 2022, with SWL's ranging from 8.49 m to 16.49 m indicating that groundwater mounding is below the rooting zone implying no negative impacts to vegetation has occurred. | | | | |
