## 1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6317/2019/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

## 2. Scope of assessment

#### 2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <a href="https://dwer.wa.gov.au/regulatory-documents">https://dwer.wa.gov.au/regulatory-documents</a>.

#### 2.2 Amendment summary

Works Approval W6317/2019/1 is held by Water Corporation (Works Approval Holder) for the Waroona Waste Water Treatment Plant (the Premises), located at 22 Drake Road Waroona, being Lot 22 on Deposited Plan 223194.

The Premises relates to the category and the assessed design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6317/2019/1.

On 9 February 2021, the department initiated an amendment to Works Approval W6317/2019/1. The amendment is limited to a typographical error whereby Condition 10, Table 4: Environmental commissioning requirements, does not reflect the correct nominal capacity of the wastewater treatment system in existing Works Approval W6317/2019/1. The Delegated Officer notes that the average annual flow of 440m³ was incorrectly provisioned in the table as the commissioning requirement, whereas the maximum treatment capacity of 880m³ should have been applied as for the assessed design capacity on the front page of the Works Approval.

#### 3. Consultation

On 12 February 2021 the Works Approval Holder waived the comment period.

#### 4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

### 4.1 Summary of amendments

Table 1 below provides a summary of the proposed amendment and will act as a record of implemented changes. The proposed changes have been incorporated into the Revised works approval as part of the amendment process.

**Table 1: Summary of works approval amendments** 

Condition no.	Proposed amendments
Condition 10, Table 4	Column 1 (Infrastructure), Row 3 (Wastewater treatment system) corrected from receiving inflow volume of 440m³/day to 880m³/day to reflect the treatment capacity rather than the average annual flow.
