Interpretation

In this licence:

- (a) the words 'including', 'includes' and 'include' in conditions mean "including but not limited to", and similar, as appropriate;
- (b) where any word or phrase is given a defined meaning, any other part of speech or other grammatical form of that word or phrase has a corresponding meaning;
- (c) where tables are used in a condition, each row in a table constitutes a separate condition;
- (d) any reference to an Australian or other standard, guideline, or code of practice in this licence:
 - (i) if dated, refers to that particular version; and
 - (ii) if not dated, refers to the latest version and therefore may be subject to change over time:
- (e) unless specified otherwise, any reference to a section of an Act refers to that section of the EP Act; and
- (f) unless specified otherwise, all definitions are in accordance with the EP Act.

NOTE: This licence requires specific conditions to be met but does not provide any implied authorisation for other emissions, discharges, or activities not specified in this licence.

Licence conditions

The licence holder must ensure that the following conditions are complied with:

General conditions

- 1. The licence holder shall immediately recover, or remove and dispose of, spills of environmentally hazardous materials including fuel, oil, or other hydrocarbons, whether inside or outside an engineered containment system.
- 2. The licence holder must take all reasonable and practicable measures to prevent stormwater run-off becoming contaminated by the activities and operations undertaken at the premises.

Premises operation

- 3. The Licence Holder shall record and investigate the exceedance of any descriptive or numerical limit, and/or target in this licence.
- **4.** The Licence Holder shall only allow waste to be accepted on to the premises if:
 - (a) it is of a type listed in Table 1; and
 - (b) the quantity accepted is below any limit listed in Table 1; and
 - (c) it meets any specification listed in Table 1

5. The Licence Holder shall ensure that the waste accepted onto the premises are only subjected to the process set out in Table 2 and in accordance with any process requirements described in that table.

- **6.** The Licence Holder shall manage the wastewater treatment vessels such that:
 - (a) overtopping of the vessels does not occur;
 - (b) there is no discernible seepage loss from the vessels; and
 - (c) vegetation and floating debris (emergent or otherwise) is prevented from growing or accumulating in the vessels.

- **7.** The Licensee shall manage the irrigation of treated wastewater such that:
 - (a) no irrigation generated run-off, spray drift or discharge occurs beyond the boundary of the defined irrigation area;
 - (b) treated wastewater is evenly distributed over the irrigation area;
 - (c) no soil erosion occurs;
 - (d) irrigation does not occur on land that is waterlogged; and
 - (e) vegetation cover is maintained over the irrigation area.
- **8.** The Licence Holder shall:
 - (a) implement security measures at the site to prevent as far as is practical unauthorised access to the site; and
 - (b) undertake regular inspections of all security measures and repair damage as soon as practicable; and
 - (c) ensure the entrance gates are closed and locked when the site is closed or unmanned.

Emissions

9. The Licence Holder shall ensure that where waste is emitted to land from the emission point in Table 3 and identified on the maps of emission points in Schedule 1 it is done so in accordance with the conditions of this licence.

Monitoring - General

- **11.** The Licence Holder shall ensure that:
 - (a) all water samples are collected and preserved in accordance with AS/NZS 5667.1;
 - (b) all wastewater sampling is conducted in accordance with AS/NZS 5667.10;
 - (c) all laboratory samples are submitted to and tested by a laboratory with current NATA accreditation for the parameters being measured.
- 12. The licence holder must ensure that monitoring is undertaken in each quarterly period such that there are at least 45 days in between the days on which samples are taken in successive quarters.
- 13. The Licence Holder shall ensure that all monitoring equipment used on the premises to comply with the conditions of this licence is calibrated in accordance with the manufacturer's specifications.

Monitoring - Emissions to land

14. The Licence Holder shall undertake the monitoring in Table 5 according to the specifications in that table.

Records and reporting

- 15. The licence holder must record the following information in relation to complaints received by the licence holder (whether received directly from a complainant or forwarded to them by the Department or another party) about any alleged emissions from the premises:
 - (a) the name and contact details of the complainant, (if provided);
 - (b) the time and date of the complaint;
 - (c) the complete details of the complaint and any other concerns or other issues raised; and

- (d) the complete details and dates of any action taken by the licence holder to investigate or respond to any complaint.
- **16.** The licence holder must:
 - (a) undertake an audit of their compliance with the conditions of this licence during the preceding annual period; and
 - (b) prepare and submit to the CEO by no later than **31 October 2022** and annually thereafter an Annual Audit Compliance Report in the approved form.
- **17.** The licence holder must maintain accurate and auditable books including the following records, information, reports, and data required by this licence:
 - (a) the calculation of fees payable in respect of this licence;
 - (b) monitoring programmes undertaken in accordance with condition 14 of this licence; and
 - (c) complaints received under condition 15 of this licence.
- **18.** The books specified under condition 17 must:
 - (a) be legible;
 - (b) if amended, be amended in such a way that the original version(s) and any subsequent amendments remain legible and are capable of retrieval;
 - (c) be retained by the licence holder for the duration of the licence; and
 - (d) be available to be produced to an inspector or the CEO as required.
- 19. The licence holder must submit to the CEO by 31 October 2023 and biennially thereafter, an Environmental Report for that two year period for the conditions listed in Table 6 and which provides information in accordance with the corresponding requirement set out in Table 6.

- **20.** The licence holder shall ensure that the Environmental Report also contains:
 - (a) an assessment of the information contained within the report against previous monitoring results and licence limits and/or targets; and
 - (b) a list of, any original monitoring reports submitted to the licence holder from third parties for the annual period and make these reports available on request.

21. The licence holder shall ensure that the parameters listed in Table 7 are notified to the CEO and in accordance with the notification requirements of the table.

Note 1: No notification requirement in the licence shall negate the requirement to comply with s72 of the Act.

Note 2: The following information shall be included: (i) when desludging is proposed to occur, (ii) the desludging method, (iii) action to mitigate potential odour impacts, and (iv) the method by which the community will be advised of the desludging activities.

- 22. The licence holder must, within 7 days of becoming aware of any non-compliance with condition 4 of this licence, notify the CEO in writing of that non-compliance and include in that notification the following information:
 - (a) which condition was not complied with;
 - (b) the time and date when the non-compliance occurred;
 - (c) if any environmental impact occurred as a result of the non-compliance and if so what that impact is and where the impact occurred;
 - (d) the details and result of any investigation undertaken into the cause of the non-compliance; and
 - (e) what action has been taken and the date on which it was taken to prevent the non-compliance occurring again.




Figure 1: Map of the boundary of the prescribed premises, emission and monitoring point (L1)
