Interpretation

In this licence:

- (c) where tables are used in a condition, each row in a table constitutes a separate condition;
- (d) any reference to an Australian or other standard, guideline, or code of practice in this licence:
 - (i) if dated, refers to that particular version; and
 - (ii) if not dated, refers to the latest version and therefore may be subject to change over time;
- (e) unless specified otherwise, any reference to a section of an Act refers to that section of the EP Act; and
- (f) unless specified otherwise, all definitions are in accordance with the EP Act.

NOTE: This licence requires specific conditions to be met but does not provide any implied authorisation for other emissions, discharges, or activities not specified in this licence.

Licence conditions

The licence holder must ensure that the following conditions are complied with:

Infrastructure and equipment

1. The licence holder must ensure that the site infrastructure and equipment listed in Table 1 and located at the corresponding infrastructure location is maintained and operated in accordance with the corresponding operational requirement set out in Table 1.

- **2.** The licence holder must ensure that no visible dust generated from the primary activities crosses the boundary of the premises.
- **3.** The licence holder must manage dust generation at the premises by:
 - (a) wetting down unsealed roads and exposed areas;
 - (b) wetting down stockpiles and operational areas;
 - (c) use hydroseeding or mulching to stabilise otherwise bare areas of soil;
 - (d) less than 2 hectares of bare soil to be open or un-rehabilitated at any one time; and
 - (e) limiting all vehicle traffic within the premises to speeds of less than 40 km/hr.
- **4.** The licence holder must manage dust generation at the premises by ensuring that all truck loads for transport outside of the premises are covered.

5. The licence holder must ensure that operations at the premises only occur between the hours of 07:00 to 17:00 and on the days Monday through to Friday, from 07:00 to 13:00 on Saturdays for rehabilitation works only and at no time on Sundays or public holidays.

Records and reporting

Records

- 6. The licence holder must record the following information in relation to complaints received by the licence holder (whether received directly from a complainant or forwarded to them by the Department or another party) about any alleged emissions from the premises:
 - (a) the name and contact details of the complainant, (if provided);
 - (b) the time and date of the complaint;
 - (c) the complete details of the complaint and any other concerns or other issues raised; and
 - (d) the complete details and dates of any action taken by the licence holder to investigate or respond to any complaint.
- 7. The licence holder must maintain accurate and auditable books including the following records, information, reports, and data required by this licence:
 - (a) the calculation of fees payable in respect of this licence;
 - (b) any maintenance of infrastructure that is performed in the course of complying with condition 1 of this licence;
 - (c) complaints received under condition 6 of this licence.
- 8. The books specified under condition 7 must:
 - (a) be legible;
 - (b) if amended, be amended in such a way that the original version(s) and any subsequent amendments remain legible and are capable of retrieval;
 - (c) be retained by the licence holder for the duration of the licence; and
 - (d) be available to be produced to an inspector or the CEO as required.

Reporting

- 9. The licence holder must:
 - (a) undertake an audit of their compliance with the conditions of this licence during the preceding annual period, and
 - (b) prepare and submit to the CEO an Annual Audit Compliance Report in the approved form by 1 March each year.




Figure 1: Map of the boundary of the prescribed premises (the corners of the premises boundary shown defined by coordinates listed in Table 3 in Schedule 2).

The boundary of the prescribed premises is shown in the map below (Figure 1).




Figure 2: Map of the site infrastructure layout at the prescribed premises. Crushing and screening operations and associated mobile machinery and equipment occur within the yellow zone with mobile elevators and excavators working in proximity.
